All memberships are subject to a \$60.00 per month house minimum fee. The house minimum is to be expended at the Club on the purchase of meals. The purchase of beverages and gratuity are not included. Dues are billed in advance at the beginning of the month. Any dues, fees or charges remaining unpaid for thirty (30) days will be subject to finance charges of 15% annually. Fees and charges remaining unpaid for a period of sixty (60) days will result in automatic suspension of all facilities use and charging privileges.

If you want to apply for a full golf membership and none are available, you must join as a Tennis member and also pay a non-refundable deposit of \$1000.00 to be placed on the golf wait list. When a golf membership becomes available you will be required to pay the difference of the golf initiation fee at the time that you joined less the amount received with your membership application.

Membership at Riverside Country Club, subject to the Bylaws and House Rules and Regulations of the Club, I offer the enclosed information with full payment of the initiation fee for your consideration. It is understood that this application shall not be binding upon Riverside Country Club until written notice of acceptance has been issued to the applicant.
