

## Membership Opportunities continued

### Non-Resident Golf Membership

Available to applicants who reside more than 100 miles from the Club for a minimum of eight (8) months per year. Membership provides full access to all of the Club's facilities and amenities to include the championship 18-hole golf course, tennis, swimming, dining, clubhouse and all social related events and activities. Privileges will be extended to the member, member's spouse and dependent children as prescribed by the Club.

**Initiation Fee:** \$2,500      \$1,500 if purchased on or before July 15, 2011

**Annual Dues:** \$3,732

New members and their sponsor will each receive up to 24 monthly credits of \$40.



### Business Sponsored Membership

Available to corporations, general partnerships, limited liability companies and sole proprietorships. There shall be one primary member who must maintain a Resident Golf Membership. The primary member may designate up to a maximum of five (5) designees who are owners, officers, or employees of the corporation, general partnership, limited liability company, or sole proprietorship. Memberships so designated are available in all membership classifications. Only one voting certificate will be issued for each Business Membership to the Primary Member. Replacing an existing designated Member is allowed, once per year, with the payment of a transfer fee equal to 10% of the initiation fee of the newly designated member. Dues for each member of the Business Sponsored Membership shall be the same as those charged in the applicable membership classification for which each individual would otherwise qualify. The corporation must guarantee such dues payments for the primary member and any additional designees.

**Initiation Fee:** \$7,500      \$5,000 if purchased on or before July 15, 2011

**Primary Monthly Dues:** \$387

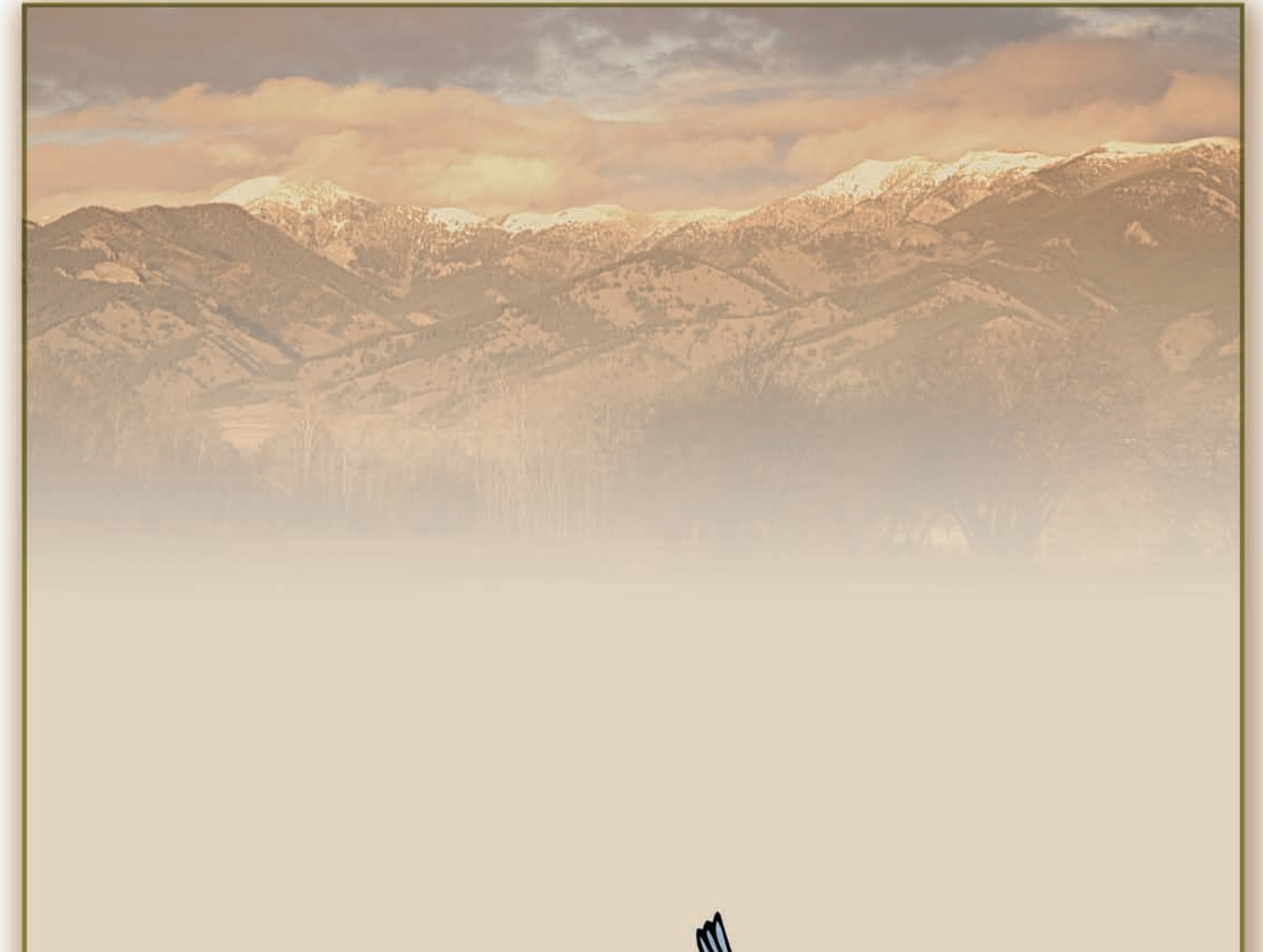
New members and their sponsor will each receive up to 24 monthly credits of \$60.

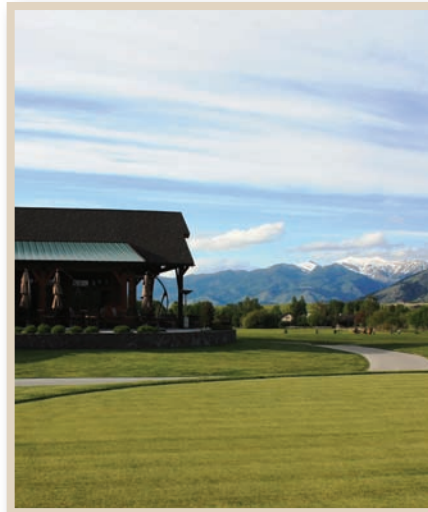
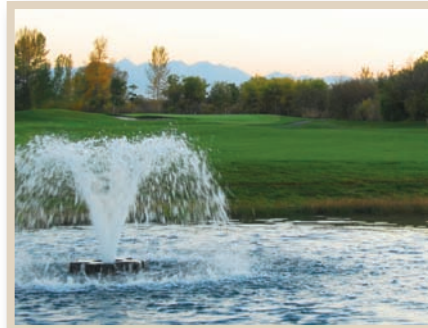

### Resident Golf Membership

Provides full access to all of the Club's facilities and amenities to include the championship 18-hole golf course, tennis, swimming, dining, clubhouse and all social related events and activities. Family privileges will be extended to the member, member's spouse and dependent children as prescribed by the Club. Single Golf privileges will be extended to the member only.

**Initiation Fee:** \$5,000      \$2,500 if purchased on or before July 15, 2011

**Family Monthly Dues:** \$387

New members and their sponsor will each receive up to 24 monthly credits of \$60.

**Single Monthly Dues:** \$343

New members and their sponsor will each receive up to 24 monthly credits of \$50.

### Junior Golf Membership

Available to applicants ages twenty-one (21) to thirty-nine (39), inclusive. Membership provides full access to all of the Club's facilities and amenities to include the championship 18-hole golf course, tennis, swimming, dining, clubhouse and all social related events and activities. Privileges will be extended to the member, member's spouse and dependent children as prescribed by the Club.

#### Ages 37-39

**Initiation Fee:** \$3,000      \$1,500 if purchased on or before July 15, 2011

**Monthly Dues:** \$282

New members and their sponsor will each receive up to 24 monthly credits of \$40.

#### Ages 30-36

**Initiation Fee:** \$2,000      \$1,000 if purchased on or before July 15, 2011

**Monthly Dues:** \$246

New members and their sponsor will each receive up to 24 monthly credits of \$35.

#### Ages 21-29

**Initiation Fee:** \$1,000      \$500 if purchased on or before July 15, 2011

**Monthly Dues:** \$211

New members and their sponsor will each receive up to 24 monthly credits of \$30.



### Social Athletic Membership

Provides full access to the Club's facilities and amenities to include tennis, swimming, dining, clubhouse and all social related events and activities. Privileges will be extended to the member, member's spouse and dependent children as prescribed by the Club.

**Initiation Fee:** \$1,500      \$750 if purchased on or before July 15, 2011

**Monthly Dues:** \$167

New members and their sponsor will each receive up to 24 monthly credits of \$25.

### Social Dining Membership

Provides full access to the Club's facilities and amenities to include dining, clubhouse and all social related events and activities. Privileges will be extended to the member, member's spouse and dependent children as prescribed by the Club.

**Initiation Fee:** \$500      \$250 if purchased on or before July 15, 2011

**Monthly Dues:** \$50

New members and their sponsor will each receive up to 24 monthly credits of \$10.

*All memberships, with the exception of Social Dining, are subject to a monthly house minimum of \$60. Social Dining members are subject to a monthly house minimum of \$75.*
